- 2. This option vests at a rate of twenty-five percent (25%) on May 1, 2013 and in 36 equal monthly installments thereafter.
- 3. This option vests as follows: (i) 211,509 shares vest at a rate of twenty-five percent (25%) on January 1, 2014 and in 36 equal monthly installments thereafter; (ii) 33,649 shares vest at a rate of twenty-five percent (25%) on April 1, 2014 and in 36 equal monthly installments thereafter; and (iii) 81,719 shares vest at a rate of twenty-five percent (25%) on May 1, 2014 and in 36 equal monthly installments thereafter. An additional 153,825 shares will begin vesting upon the closing of the Issuer's initial public offering, at a rate of twenty-five percent (25%) on the one year anniversary of the date of closing of the Issuer's initial public offering and in 36 equal monthly installments thereafter.
