- This option vests as follows: (i) 67,048 shares vest at a rate of twenty-five percent (25%) on January 1, 2014 and in 36 equal monthly installments thereafter; (ii) 10,315 shares vest at a rate of twenty-five percent (25%) on April 1, 2014 and in 36 equal monthly installments thereafter; and (iii) 25,788 shares vest at a rate of twenty-five percent (25%) on May 1, 2014 and in 36 equal monthly installments thereafter.
